Name	Research on the Implementation of the Directive on the Right to Information in Criminal Proceedings
Period	August 2015 – June 2016
Partners	Lithuania, Austria, Italy, Spain, Poland, Ireland
Goal	The project aims to contribute to successful implementation of the 2012/13/EU Directive on the Right to information in Criminal Proceedings which was adopted by the European Parliament and the Council of Europe on 22 of May. This directive determines minimal standards of delivery on information for suspects and accused in criminal proceedings.
Results of the project 2016	<ol style="list-style-type: none"> 1. A research on implementation of the Directive on the right to information in criminal proceedings in Lithuania was conducted. In the framework of the research national legislation was analysed, lawyers, police investigators and prosecutors were interviewed. 2. Coordination of the delivery of the analogous studies in six other Member States.

Period	1 April 2016 – 31 December 2017
Partners	Lithuania, Portugal, Finland, Malta
Goal	The project aims to examine online support availability for victims of crime in European Union, its provided opportunities, and to create tools for victim support workers, who wishes to implement this model in their job.
Results of the project 2016	<ol style="list-style-type: none"> 1. Analysis of Lithuanian online support tools and their effect. 2. Meetings with services, which successfully provide online support for victims of crime in European Union member states. 3. Development of procedures and guidelines for victims support workers. 4. Meetings with key stakeholders to assess possibility of creating online support system for victims in Lithuania. 5. Creating and disseminating a survey about remote assistance for victims to organizations that provide this kind of assistance.

Period	1 May 2016 – 30 September 2016
Gaol	The project aims to strengthen HRMI’s financial independence and sustainability by creating a new product – e-learning course on the legal (in)capacity reform in Lithuania.
Results of the project 2016	<ol style="list-style-type: none"> 1. Online learning course “Legal (in)capacity reform in Lithuania: the change of attitude and legal regulation“ was developed on the e-learning platform www.without-limits.eu. The course consists of six video lessons supplemented with reading materials and self-assessment tests. 2. E-learning course was publicized on social networks through various visual tools. 3. All Lithuania’s city municipalities were introduced to e-learning course and welcomed to join. 4. 60 social workers, lawyers, public servants and other specialists joined E-course.

Name	Effective Implementation of the right to a Lawyer and Legal Aid Under the Stockholm Programme
Period	1 June 2016 – 1 April 2018
Partners	Lithuania, Bulgaria, Hungary, Poland, Slovenia
Goal	The project aims to strengthen the procedural rights of suspects and accused in criminal proceedings by increasing layers’ (and other legal professionals’) knowledge and the capacity to apply the Directive 2013/48/ES (“Right of access to a lawyer directive”) and Recommendation C(2013) 8179/2 (“Right to legal aid recommendation”).
Planned activities	<ol style="list-style-type: none"> 1. National study to assess the scope and quality of access to a lawyer and legal aid in Lithuania through case-file research, focus groups and in-depth interviews. 2. Production of handbooks on the implementation of the EU and ECtHR-level standards on the right to a lawyer and right to legal aid.



	3. Roll out of capacity-building workshops for key stakeholders and launch of the e-learning course in platform www.without-limits.eu .
Results of the project 2016	<ol style="list-style-type: none"> 1. Vilnius city district and county courts, Šiauliai, Panevėžys, Kaunas and Klaipėda district courts were visited, where criminal cases were studied. 2. Using criminal cases material, 157 forms were filled in which later were systemized into database. Collected data will be used further in the project.

Goal	The project aims to contribute to correct implementation of the 2012/13 EU Directive on the right to information in criminal proceedings by producing alternative Letter of Rights (LoR) and implementing it in national jurisdictions.
Planned activities	<ol style="list-style-type: none"> 1. National research in Lithuania on accessibility of the right to information in criminal proceedings. 2. Development of alternative LoR. 3. Producing comparative report to European Commission.
Results of the project 2016	National research in Lithuania was conducted looking at the legal framework on the right to information in criminal proceedings and its comprehensibility. Study report was prepared.

Goal	The project seeks to provide a human insight into the treatment of people following surrender under the European Arrest Warrant (EAW), to evaluate this practice through EU legal standards and to support effective implementation of Decision 2002/584/JHA on the European Arrest Warrant.
Planned activity	<ol style="list-style-type: none"> 1. Monitoring cases on people surrendered under the EAW. 2. Monitored cases' results analysis. 3. Producing three to six human stories who were send to Lithuania

	under EAW.
Results of the project 2016	<ol style="list-style-type: none"> 1. Together with Lithuania Bar Association roundtable discussion was held about EAW application in Lithuania and human rights protection in such cases. 2. Court proceedings monitoring was started.

Name	Developing an EU Training Module for the Victims' Directive	
Period	1 June 2016 – 1 April 2018	
Partners	Lithuania, Ireland, Portugal, Hungary, Slovenia	
Goal	The project aims to organize a training pursuant to Directive 2012/29/ES, which establishes minimum standards on the rights, support and protection of victims of crime. This directive replaces previous framework decision of Council 2001/220/TVR (Rights of victims of crime Directive) and in this way contributes to rights of victims support in Lithuania.	
Planned activities	<ol style="list-style-type: none"> 1. Assessment of the training needs among different specialist in Lithuania. 2. Development of training programme and training guide. The training will cover: (1) victims' needs; (2) EU Victims Directive; (3) interviewing child victims; (4) interviewing persons with disabilities; (5) interviewing victims with special protection needs. 3. Training sessions for police officers, prosecutors and lawyers in Vilnius organization (60 persons). 4. Development of an e-course based on the training programme using the e-learning environment Be-ribu.lt. 5. International conference in Dublin to discuss the impact of the training on targeted groups in partner states.

Goal	<p>The primary objective of the project is to assist in raising awareness on the major changes to the data protection landscape in Lithuania brought about by the General Data Protection Regulation, and to advance the understanding of a right to personal data as a fundamental human right and the civil society's role in its protection.</p>
Results of the project 2016	<ol style="list-style-type: none"> 1. Representative survey of Lithuanian residents and 50 Lithuanian companies. 2. Two studies released: „The Privacy Paradox: the Lithuanian Public's Perceptions of Data“ and “The Preparedness of Lithuanian Business to Implement GDPR“. 3. During the “Digital Rights Forum 2016” in Vilnius, findings of the studies were discussed as well as effective implementation of EU data protection reform in Lithuania. Forum was attended by representatives from the European Commission, European Data Protection Supervisor Office, Data Protection Institutions from the Baltic countries as well as lawyers and other experts. <div style="text-align: center;">  </div>

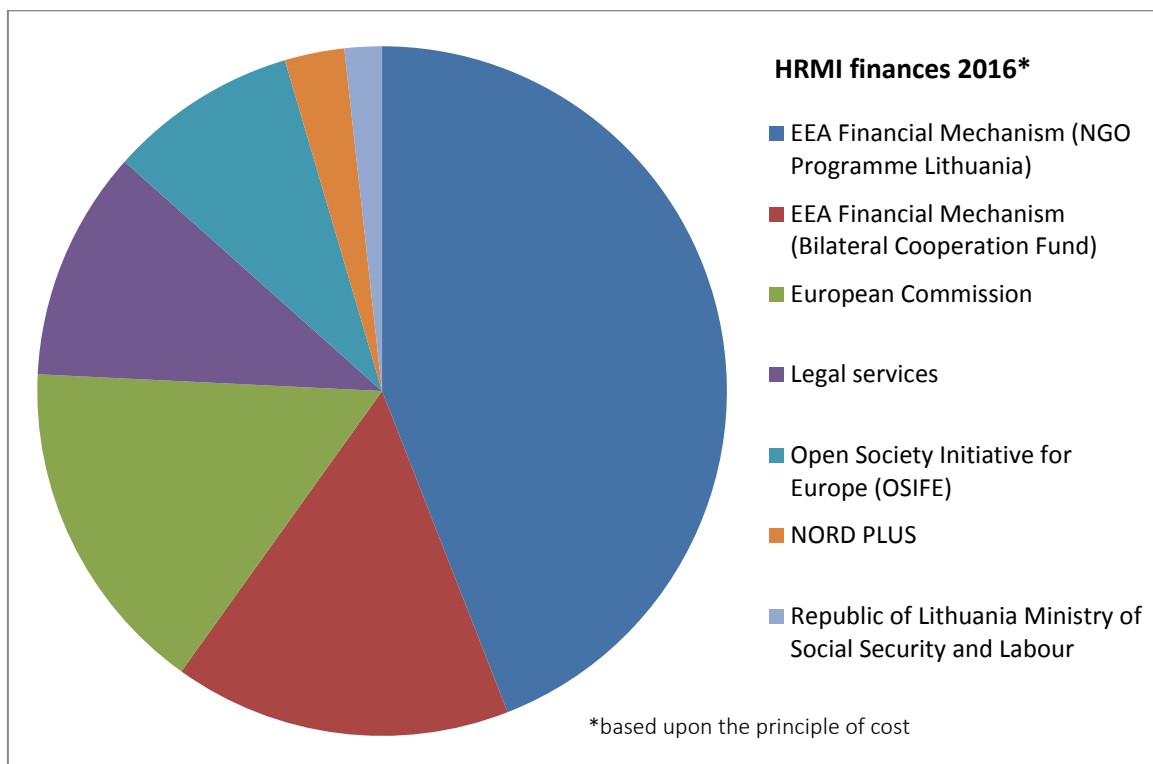

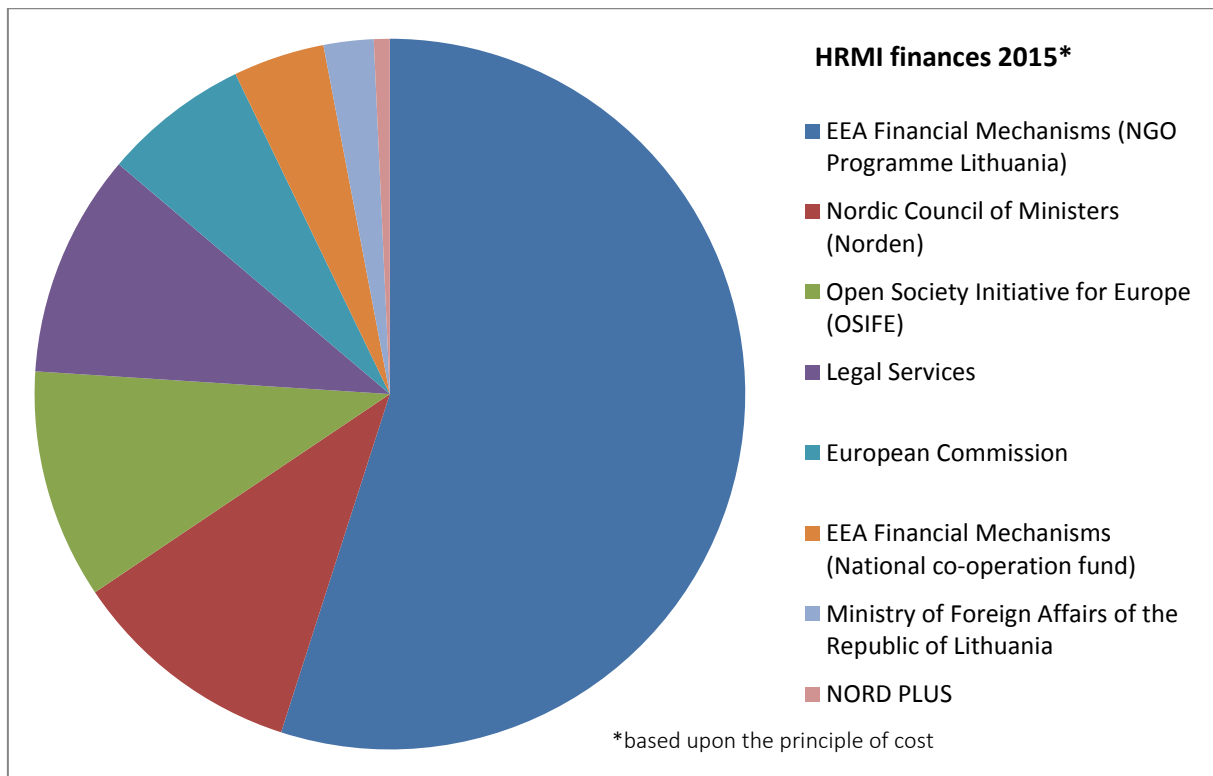

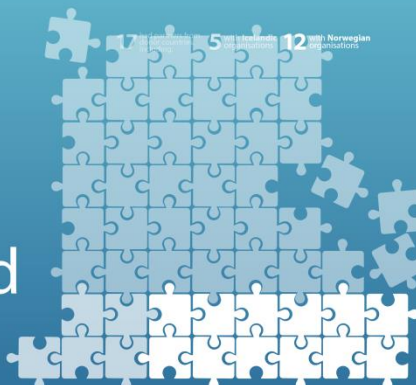
